COVID-19 INFORMED CONSENT AND WAIVER OF LIABILITY FOR PARTICIPATION IN HIGHER-RISK SPORT (Updated 2/2/21)

In consideration of being allowed to participate in a higher risk sport at Manlius Pebble Hill School (MPH), the undersigned acknowledge(s) that (please initial):

____ Participation in a higher-risk sport places my child at risk to SARS-CoV-2.

____ SARS-Co-V-2 can lead to serious medical conditions and death for people of all ages.

____ Symptomatic and asymptomatic individuals can spread the virus.

____ Masking, distancing, and other mitigation measures reduce, but do not eliminate risk.

____ At present, it cannot be predicted who will become severely ill if infected.

____ The long-term effects of COVID-19 are, at present, unknown; even people with mild cases may experience long-term complications.

____ There is a significant risk of transmission to those in the home of infected student-athletes.

____ Older people and people with underlying health conditions are at higher risk of serious disease.

____ As a condition to my/my child's participation in a higher-risk sport, I will fully cooperate and participate in any COVID-19 contact tracing, case investigation and will adhere to any isolation or quarantine order.

____ I/my child will comply with all health and safety rules imposed by Manlius Pebble Hill School.

____ At any time, MPH may decide to halt to practices and /or withdraw its participation in scheduled games to safeguard the health and well-being of student athletes and the overall MPH community.

____ I authorize Manlius Pebble Hill and/or the Onondaga County Department of Health to test my for COVID-19 infection as scheduled by Manlius Pebble Hill.

By signing this agreement, I acknowledge the contagious nature of SARS-Co-V-2 and voluntarily assume the risk that I/my child may be exposed to or infected by SARS-CO-V-2 while participating in a higher-risk sport and that such exposure or infection may result in personal injury, illness, permanent disability, and death.

I understand that the risk of becoming exposed to or infected by SARS-CO-V-2 by participating in a higher-risk sport may result from the actions, omissions, or negligence of Manlius Pebble Hill School, its officers, employees, agents, volunteers and others, and program participants and their families.

I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any SARS-Co-V-2-related infection or injury to myself or my minor child (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that I/my child may experience or incur in connection with my/my child's participation in the practices, activities and competitions of a higher-risk sport.

I understand and agree that this release includes any claims based on the actions, omissions, or negligence of the Manlius Pebble Hill School, its officers, employees, agents, volunteers and others, and program participants and their families.

I hereby release, covenant not to sue, discharge, and hold harmless Manlius Pebble Hill School, its officers, employees, agents, volunteers and others, and program participants and their families, including all liabilities, claims, actions, damages, costs, or expenses of any kind arising out of or relating to any SARS-Co-V-2 infection or injury due to my or my child's participation in a higher-risk sport.
